

Mt. Skinner Bulk Sampling - Summary

Of the 20 lots of ore produced by the bulk sampling on the Victoria vein between 1992 and 1996, 12 were shipped to the Premier Gold mill in Stewart, and 8 were shipped to the Trail smelter. For control purposes all lots were sampled at the loading pad by the shipper (Ottarasko Mines Ltd.) according to a procedure which remained constant for all 20 shipments, and these samples were all fire assayed by Acme Labs of Vancouver. Each lot was then resampled and assayed by the receiving mills. The first 5 lots sent to the Premier mill were sampled and assayed at reception by the mill's own laboratory; this proved entirely unsatisfactory to Ottarasko, and a new processing contract was negotiated which provided for a new procedure and assaying by an independent lab. All 8 lots sent to the Trail smelter were sampled and assayed by the smelter according to their standard procedure, with a split provided to Ottarasko for a control assay by SGS of Vancouver. A summary of the comparative results follows:

The official production result, and amount on which payments were based, is 1294.4 oz Au. It appears however that the sampling/assaying procedures used by both Ottarasko and the Premier mill understate the gold content very seriously and that, had all the shipments been sent to Trail, the overall production results would have been approximately 1650 ounces (i.e. $\frac{1382.4 \times 119.7}{100}$), for an overall bulk sample

grade of 2.14 oz/ton Au (instead of 1.674 oz/ton as calculated when using the Premier numbers)

The control assays by SGS confirmed the assay numbers provided by the Trail smelter very closely.
